



#### National Institute for Education

The National Institute for Education is directly managed by the Ministry of Education, Science, Research and Sport of the Slovak Republic. It provides professional-methodological management of schools and school facilities, as well as educational activities for pedagogical staff. Its main responsibilities are curricular changes, applied pedagogical research; professional and methodological counselling; experimental verification; pilot educational projects; reforms and changes in the content of education and training; state educational programmes; sectoral research; professional- methodological management of schools especially in the development of school educational programmes; preparation of pedagogical documents for schools and school facilities in general education and further training of pedagogical staff.

### PaedDr. RENÁTA SOMOROVÁ NATIONAL INSTITUTE FOR EDUCATION, SLOVAK REPUBLIC

Renáta is a research and development professional at the National Institute for Education, deputy director of the Department for the Design and Development of State Educational Programmes. She was a head of the Department for Slovak Language and Literature, secretary of the Central Subject Committee for Slovak Language and Literature. She managed the grant project *The origins, objectives and concept of curriculum redesign of the subject Slovak language and literature at* 

primary and secondary schools and the grant project Standardization of levels to master Slovak language. She prepared and implemented national activities for teachers of Slovak language and literature at primary and secondary schools in the framework of in-service training. She has been involved in the development of tests for Slovak language and literature within the framework of electronic testing and the national project Modern education, digital education for general educational subjects. She prepared language courses and methodological recommendations for teaching Slovak language – basic and advanced state language courses for children of foreign nationals in the Slovak Republic, cooperated in developing the mid-level course Curriculum of Slovak studies for children of foreign nationals in the Slovak Republic, language courses, methodological guides, recommendations as a part of the publication Children of migrants in the educational process in terms of respecting human rights and children's rights. She provides methodological and didactic guidance for the development of educational system concepts, the development of pedagogical documents for primary and secondary schools, and the preparation of draft concepts and projects of methodological and didactic services for primary and secondary schools.



#### PhDr. DENISA ĎURANOVÁ NATIONAL INSTITUTE FOR EDUCATION, SLOVAK REPUBLIC

Denisa is a research and development professional at the National Institute for Education in the Slovak Republic. She studied teaching general educational subjects: English language and literature – Philosophy at the Constantine the Philosopher University in Nitra. Her postgraduate study in the study field of political science focused on the comparison of social policy among EU member states. She has been working in the field of education since 2001. During her professional life she was as a coordinator of professional activities related to the projects aimed at enhancing professional

competencies of teachers. Denisa also deals with teaching English as a foreign language, development of state educational programmes and school educational programmes for foreign languages, language policy, language policy projects within European context, as well as international cooperation and communication. During her professional life she managed a project aimed at improving the university education of future teachers of Slovak language and literature at primary and secondary schools with the language of national minority as a language of instruction using the teaching methods of foreign languages. She was a coordinator of professional activities related to the projects aimed at enhancing professional competencies of teachers, and standardization of levels to master Slovak language.
